CERTIFIED FIRE DEPARTMENT

PREMIUM CREDITS FOR RURAL FIRE PROTECTION DWELLING FIRE INSURANCE AND COMPREHENSIVE DWELLING POLICY INSURANCE

The Mississippi Insurance Department has authorized Mississippi State Rating Bureau member companies to grant a fire insurance premium credit of 5% to Class 10, or unprotected, dwelling fire insurance policies and Comprehensive Dwelling policies where rural fire protection meets certain recognized standards. This fire insurance premium credit shall be made applicable to dwelling fire insurance policies and Comprehensive Dwelling policies by endorsement where a certified fire department station is located within five (5) road miles travel distance.

Fire Departments whose stations are located outside the limits of 3rd through 9th Class municipalities or fire district, and who are certified and listed by the Mississippi State Rating Bureau as meeting minimum standards of equipment, organization, training and alarm facilities, will qualify as meeting the requirements of this fire insurance credit procedure. Fire departments whose stations are located within a 3rd through 9th Class municipality or legal fire district will also qualify as meeting the requirements of this fire insurance credit procedure.

A reproducible copy of an Application for Certified Fire Department Designation required of Fire Departments whose stations are located outside the limits of 3rd through 9th Class municipalities and legal fire districts follows, together with minimum requirements for such designation.

APPLICATION FOR CERTIFIED FIRE DEPARTMENT DESIGNATION

If a fire department located outside the limits of a 3rd through 9th Class municipality or legal fire district meets the criteria for recognition as a certified fire department, then the Mississippi State Rating Bureau should be so advised in order that an Application for Certified Fire Department Designation may be furnished the appropriate fire department official for completion and return. If the application is complete and proper, a survey of the fire department facilities will be scheduled. If the survey determines that the fire department is eligible for certification, then a listing in this respect will be completed and the Fire Department, insurance agents and insurance companies of immediate interest will be notified.

DWELLING FIRE INSURANCE

CLASS 10 PREMIUM CREDIT FOR CERTIFIED FIRE DEPARTMENT

A credit of 5% shall be allowed on 10th Class dwellings located with five (5) road miles travel distance from a responding fire department fire station located in a 3rd through 9th Class municipality or fire district. (Such fire department located in a 3rd through 9th Class municipality or fire district is designated as a certified fire department for the purposes of this premium credit).

A credit of 5% shall be allowed on 10th Class dwellings located within five (5) road miles travel distance from a fire station of a responding fire department located outside the limits of a 3rd through 9th Class municipality or fire district provided the fire department is certified and listed by the MSRB as meeting the following minimum requirements.

- (1) Fire Department equipment should consist of a reliable tanker truck with a minimum capacity of 1,000 gallons and equipped with at least a 250 g.p.m. pump. The tank should have a six-inch top fill. Equipment to be carried on the tanker should consist of thirty (30) feet of 2 ½' hard suction hose (3' hard suction hose with 2 ½' couplings would be better), two 150-foot pre-connected 1 ½' fire hose with combination nozzles and 100-feet of spare 1 ½' fire hose, 400-feet of 2 ½' double jacketed fire hose, spanner and hydrant wrenches, 24-foot extension and 10-foot attic ladders, Underwriters Laboratories approved Class B-C fire extinguisher(s) with minimum thirty (30) BC rating, two (2) 5-gallon back packs, grass flaps, hand lights, shovel, axe, and a pike pole. Additional equipment that would be desirable are a booster reel, thirty (30) minute self contained breathing apparatus and a float pump. Based on conditions, some variations of a minor nature in these requirements may be acceptable. Adequate housing is required to protect the equipment.
- The fire department should be an organized and actively training volunteer and/or paid fire department consisting of a chief, assistant chief and ten (10) or twelve (12) other dependable members. Due to local circumstances and work schedules of the fire fighters it might be necessary to increase the overall size of the department so that a minimum of four (4) or five (5) would respond to all structural fires. A regular monthly training program should be maintained so that members might retain their skills with the equipment and broaden their knowledge of fire fighting tactics. Members should take advantage of local training sponsored by the State Fire Academy, #1 Fire Academy USA, Jackson, Mississippi 39208.
- (3) There should be a reliable means to sound a fire alarm together with an established method of response. The alarm system should be such that the fire fighters will respond in a minimal time frame.

The credit is based on fire premiums derived from the 10th Class premium chart of the Dwelling Manual.

COMPREHENSIVE DWELLING POLICY INSURANCE

CLASS 10 PREMIUM CREDIT FOR CERTIFIED FIRE DEPARTMENT

A credit of 5% shall be allowed under Coverage Group A on 10th Class dwellings written under the CDP Policy when located within five (5) road miles travel distance from a responding fire department fire station located in a 3rd through 9th Class municipality or fire district. (Such fire department located in a 3rd through 9th Class municipality or fire district is designated as a certified fire department for the purposes of this premium credit).

A credit of 5% shall be allowed under Coverage Group A on 10th Class dwellings written under the CDP Policy when located within five (5) road miles travel distance from a fire station of a responding fire department located outside the limits of a 3rd through 9th Class municipality or fire district provided the fire department is certified and listed by the MSRB as meeting the following minimum requirements.

- 1. Fire Department equipment should consist of a reliable tanker truck with a minimum capacity of 1,000 gallons and equipped with at least a 250 g.p.m. pump. The tank should have a six-inch top fill. Equipment to be carried on the tanker should consist of thirty feet of 2 ½' hard suction hose (3' hard suction hose with 2 ½' couplings would be better), two 150-foot pre-connected 1½' fire hose with combination nozzles and 100-feet of spare 1½' fire hose, 400-feet of 2 ½' double jacketed fire hose, spanner and hydrant wrenches, 24-foot extension and 10-foot attic ladders, Underwriters Laboratories approved Class B-C fire extinguisher(s) with minimum 30 BC rating, two 5-gallon back packs, grass flaps, hand lights, shovel, axe, and a pike pole. Additional equipment that would be desirable are a hooster reel, 30 minute self contained breathing apparatus and a float pump. Based on conditions, some variations of a minor nature in these requirements may be acceptable. Adequate housing is required to protect the equipment.
- 2. The fire department should be an organized and actively training volunteer and/or paid fire department consisting of a chief, assistant chief and ten (10) or twelve (12) other dependable members. Due to local circumstances and work schedules of the fire fighters it might be necessary to increase the overall size of the department so that a minimum of four (4) or five (5) would respond to all structural fires. A regular monthly training program should be maintained so that members might retain their skills with the equipment and broaden their knowledge of fire fighting tactics. Members should take advantage of local training sponsored by the State Fire Academy, #1 Fire Academy USA, Jackson, Mississippi 39208.
- 3. There should be a reliable means to sound a fire alarm together with an established method of response. The alarm system should be such that the fire fighters will respond in a minimal time frame.

The credit is based on premiums derived from the 10th Class Coverage Group A premium chart of the Comprehensive Dwelling Policy Manual.

Q. Protection Class 10

Certified Fire Department - All Forms

The following credit shall be given on policies for dwellings falling into the following defined areas, unless the insurer is already providing a deviation credit of 3% or more for dwellings in these areas.

FIRE DEPARTMENT GRADED CLASS 9 or BETTER

The premium for a dwelling located in a Class 10 area shall be reduced as noted below if it is situated within five (5) road miles travel distance from a responding fire department fire station in a 3rd through 9th Class municipality or fire district. (Such fire department located in a 3rd through 9th Class municipality or fire district is designated as a certified fire department for the purposes of this premium credit).

FIRE DEPARTMENT GRADED CLASS 10

The premium for a dwelling located in a Class 10 area shall be reduced as noted below if it is situated within five (5) road miles travel distance from a responding certified fire department fire station outside the limits of a 3rd through 9th Class municipality or fire district.

Contact the Mississippi State Rating Bureau to determine if the municipality or fire district is designated as a certified fire department.

If eligible under 1. or 2. above, multiply the Homeowners or Fine Arts premium shown in the BASIC PREMIUM CHART by a factor of .97.
